For info Bureau, WFO [1161] advised SA DONALD HOETING on 4-4-61, he learned last evening from members of Movimiento Revolucionario Del Pueblo (MRP) that an attempt to invade Cuba is expected to take place either at the end of this week or the beginning of next week, 4-10-61.

In support of this, informant stated that MIRO CARDONA, recently selected Provisional President of Cuba, has been working very closely with CIA and visited the anti-CASTRO camp located in Guatemala with officials of CIA within the last week.

With regard to the above, informant advised that MANOLO RAY, head of MRP, has already ordered the underground in Cuba to assist and cooperate with any invasion force which might land in Cuba.

Informant stated he would keep Bureau advised of developments.
