Enclosed herewith for the Bureau are 3 copies of a letterhead memorandum setting forth information concerning above-captioned subject matter, and 3 copies of a reliability memorandum setting forth the reliability of the informant used.

In addition, there is also enclosed for the information of the Bureau the rough draft notes of MANUEL RAY which were used by RAY preparatory to discussions with Dr. ANTONIO DE VARELA and other leaders of the FID. These notes were furnished the NYO by ZACHARY DE CASTEL on 3/27/61, and he stated that care should be taken in the future utilization of those notes, since RAY left them in DE CASTEL's apartment.

NY P-1 is ZACHARY DE CASTEL, who is a friend of MANUEL RAY and who has allowed RAY to reside in his apartment during recent visits to New York.

DE CASTEL on 3/24/61 advised that RAY was leaving for Miami, Florida, at 3 P.M., 3/24/61, but intended to return to New York during the week of 3/27/61 and would be staying at DE CASTEL's apartment, 8 West 74th St., NYC.

The enclosed memoranda have been classified "Secret" because they contain information the disclosure of which could be detrimental to the best interests of the United States and the National Security.
