attended by foreign diplomatic personnel. Current topics of
importance are discussed and members agree to discuss the
subject matter of the Forum outside of the meeting. The
meetings are well organized, and a principal speaker is
designated and invited, and usually a general discussion
among the members pertaining to the meeting's subject matter
follows. (X)
