SAMUEL M. GIANCANA

On June 17, 1959, [redacted] Potential Criminal Informant, advised that he has reason to believe that Giancana and other syndicate members are attempting to corner the bail bond business in Chicago and other large cities. In this connection, [redacted] was contacted by Mike Brodtkin, a syndicate lawyer in Chicago, in order to feel out his, the informant's, attitude toward allowing the outfit to take over the bonding business of the colored section in Chicago. In order to do this, it would become necessary for Giancana to visit with Ed and ~~George~~ Jones, former Negro policy wheel operators on Chicago's South Side, who are now in Mexico City. The informant said that the son of an Italian hoodlum, whose name he cannot recall, has recently spent some time with Ed Jones in Mexico. According to the informant, Jones has been to Switzerland on frequent occasions, but he does not know for what reason. LL 9
