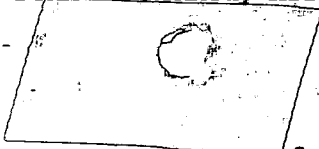

SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. CG 6443-C.  
ADVISED THAT LESLIE KRUSE, GIANCANA ASSOCIATE, RECENTLY  
RETURNED FROM FLORIDA, WHERE HE HAD BEEN STAYING AT THE  
LAKE WORTH RESIDENCE ALLEGED IN PAST TO BE OWNED BY GIANCANA.  
KRUSE COMPLAINED TO INFORMANT THAT "KELLOGG HAS BEEN GIVING  
HIM A BAD TIME THERE." EXTENSIVE INVESTIGATION HAS BEEN  
CONDUCTED BY THE MIAMI DIVISION RE FLORIDA RESIDENCE, AND  
KELLOGG MENTIONED IS PROBABLY SA RICHARD B. KELLOGG, MIAMI  
DIVISION. CG 6343-C\*, ADVISED THIS DATE THAT KRUSE HELD  
A BRIEF CONVERSATION WITH ANTHONY ACCARDO AND JACK CERONE,  
BOTH CHICAGO TOP HOODLUM SUBJECTS, AND DISCUSSED THE FACT  
THAT "HEAT" IS ON ALL OVER, MADE PARTICULAR REFERENCE TO  
RECENT OCCURRENCES IN FLORIDA WHEREBY SOME SHERIFFS HAVE  
BEEN RECENTLY INDICTED. ACCARDO ACCUSED THE FEDERAL GOV-  
ERNMENT OF BEING RESPONSIBLE FOR MOST OF THE INTENSIVE  
INVESTIGATIONS, AND ADMITTED THAT "MOST OF THE INTERSTATE  
STUFF HAS STOPPED" BUT SAID THAT THE GOVERNMENT COULD DO  
NOTHING ABOUT THE INTRA STATE ACTIVITY. INFORMANTS AND  
OTHER SOURCES HAVE NOT INDICATED THE PRESENCE OF GIANCANA  
THIS DIVISION DURING PAST SEVERAL DAYS. ARMED AND DANGEROUS.
