On 8/17/65 SAM JOHNSON, U.S. Customs Agent, Tampa, was contacted for any information indicating that ORLANDO BOSCH planned to commit any sabotage or to move his headquarters to Tampa. He consulted his office in Miami and was unable to disclose [identity of the police authority mentioned in CIA's memorandum] set forth in referenced Miami LHM.

On 8/17/65 JACK DE LA LLANA, Tampa PD, advised he had no information to indicate that BOSCH intended to move any of his operations to Tampa. He further advised he received no information from his sources that would indicate that BOSCH, while in Tampa for the meeting of August 14, 1965, indicated any plans for sinking vessels of any type.
