Attached for New York and Miami are single copies of
CIA Intelligence Information Cable TDCSDB-318/00128-66 dated 1/12/66.

Retel instructed that you contact the local offices of
Bureau of Customs in New York and Miami to determine if that agency
has a current investigative interest in subject. In the course of
such contacts you are to alert Customs to the contents of the
enclosed CIA cable. In addition, Miami is to contact CIA at the
local level to ascertain whether that Agency has any operational
interest in the activities described in enclosure.

If it is learned that the data in the CIA cable is not
current investigative or operational interest to the above agencies,
the following is to be done:

New York and Miami are to promptly canvass appropriate
Haitian and Cuban sources and informants to develop all available
information concerning these allegations. Miami is to include
contact with MM 635-S, MM 639-S, and Evilio Alpizar Perez concerning
subject's alleged dealings with MIRA with MM 639-S with regard to
subject's reported discussions with Jose Peruyoro Rodriguez and with
Carlos Zaraga Martinez regarding subject's alleged approach to
Zacarias Acosta Garcia.
