No information was located through a search of San Juan indices which would tend to further identify the SAN PEDRO who is allegedly connected with MIRR.

Information contained in the letterhead memorandum accompanying referenced letter concerning the alleged plot to transport explosives to sabotage a ship in Puerto Rico was brought to the attention of SJ 533-S and SJ 492-S on December 22, 1965.

To date, San Juan has received no information from sources which would tend to substantiate above allegation.
