SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. JOSEPH CHARLES BORSELLINO,

ALLEGED ASSOCIATE AND QUOTE ADVANCED AGENT UNQUOTE FOR SAM GIANCANA INTERVIEWED THIS DATE AND CLAIMED THAT HE HAS NEVER MET GAINCANA, HAS NEVER BEEN IN HIS COMPANY NOR HAS HE EVER SEEN GIANCANA. GIANCANA ALLEGEDLY HAS INTEREST IN HOLIDAY MOTEL, LAKE DELTON, WISC. MILWAUKEE DIVISION ADVISED HOLIDAY MOTEL OWNED BY TRAFICANTE BROTHERS, INC., ALL FROM CHICAGO AREA. EFFORTS WILL BE MADE TO INTERVIEW TRAFICANTE BROTHERS RE POSSIBLE INTEREST OF GIANCANA. INQUIRY BY MIAMI TO DATE HAS FAILED TO REFLECT GIANCANA-S NAME TO BE ASSOCIATED WITH PROPERTY AT ONE NINE ZERO TWO NOTRE DAME BOULEVARD, LAKE WORTH, FLA., HOWEVER, DICK BURNS AND OTHER PERSONS FROM CHICAGO WHO HAVE ALLEGEDLY ASSOCIATED WITH GIANCANA ARE KNOWN TO BE CONNECTED WITH THE BUILDING AND OR SALE OF THIS PROPERTY.
