It was agreed for source to contact Dr. JOSEPH DESIMONE, brother of deceased La Cosa Nostra "Boss" FRANK DESIMONE, and relate to him the details of source's previous contacts with JOSEPH CIVELLO of Dallas concerning the Teamsters Pension Fund Loan for the purpose of purchasing the Riviera Hotel, Las Vegas and the involvement of NICK CIVELLA of Kansas City. Source would attempt to induce DESIMONE to go to Dallas to determine from JOE CIVELLO why CIVELLO was no longer interested.

Source did contact Dr. DESIMONE on the same day and requested DESIMONE to come to source's office, which he did. Source explained the situation and DESIMONE said that JOE CIVELLO's cousin is in Los Angeles and he talks to him all the time. Dr. DESIMONE said he will immediately go to Dallas to contact JOE CIVELLO to find out why CIVELLO has taken this non-interested position in helping source obtain the loan.

Because source had previously told Dr. DESIMONE that he would receive his brother FRANK's share, DESIMONE is acting in his own interest to assure that there is a share to receive.

Source will advise the results of DESIMONE's meeting with CIVELLO.
