Re Chicago airtel to Bureau, 10/5/67, regarding a proposed meeting of Chicago Division Agents with Milwaukee informant MI 623-C-TE.

On 10/17/67, SAs CARLYLE N. REED and DANIEL E. BRANDT of the Milwaukee Division were in contact with MI 623-C-TE at Milwaukee. Informant stated he could make himself available for a meeting with Chicago Agents. He is unavailable on Fridays, and the most convenient day of the week would be a Monday. He would be available on 10/30/67, if that date does not conflict with the schedule of the Chicago Agents who desire to interview this informant.

Chicago should advise as to whether or not 10/30/67 is a satisfactory date. Thereafter, Milwaukee will notify Chicago as to an exact time and place after recontact with the informant. Time and place will be in keeping with security precautions necessary to avoid compromising MI 623-C-TE.
