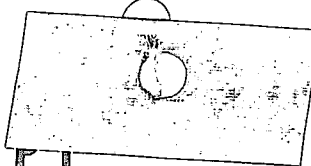
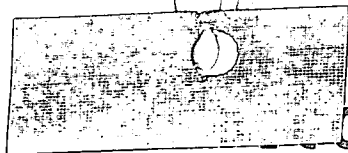

CG 6512-C-TE TODAY ADVISED HE WAS FREQUENTING THE CICERO, ILLINOIS AREA AND IN THIS CONNECTION TALKED TO TOP HOODLUM JOEY AIUPPA AND AIUPPA'S BROTHER, SAM. IN THE CONVERSATION THAT FOLLOWED THE INFORMANT ASKED AIUPPA WHY HE WAS GETTING THE COLD SHOULDER IN THE CICERO AREA INASMUCH AS OTHERS IN A LIKE POSITION HE HAD BEEN IN THE PAST ARE NOW ALLOWED FREE RUN OF THE CICERO GAMES. HE SPECIFICALLY NOTED CHUCK NICOLETTI AND FRANK TEUTONICA. THE INFORMANT WAS ADVISED THAT TEUTONICA IS ON BAD PAPER WITH THE OUTFIT IN CICERO AND HAS BEEN RUN OUT OF TOWN. INFORMANT WAS UNABLE TO OBTAIN FURTHER INFORMATION RE THIS SITUATION. INFORMANT HAD BEEN DEALING IN NARCOTICS WHICH THE CHICAGO GROUP WILL NOT ALLOW. (u)

INFORMANT INDICATED THAT GAMBLING IS ABAIN OPERATING ON A SNEAK BASIS IN THE CICERO AREA. IT IS TO BE NOTED THAT TWO ESTABLISHMENTS CLOSELY LINKED TO GIANCANA WERE VISITED BY THE INFORMANT, ONE OF WHICH WAS RECENTLY RAIDED BY THE COOK COUNTY STATES ATTORNEY'S POLICE. A SMALL GAME WAS OBSERVED IN PROGRESS AT THIS LOCATION BY INFORMANT TODAY. GIANCANA ARMED AND DANGEROUS. (u)
