I. IRVING DAVIDSON

Davidson is of the opinion that "the deal" is even better now because he thinks Mr. Castro (Fidel Castro, Prime Minister of Cuba) is going to fall. (S) (u) **SECRET**

Davidson is traveling to New York on May 5, 1959, and from there will fly to Miami, Florida and eventually to Nicaragua where he expects to remain for four days. (S) (u)

The informant also learned that Davidson was scheduled to meet [Avraham Salmon] at the Mayflower Hotel, Washington, D.C. at 6 pm on May 4, 1959. (S)

The ["Diplomatic List"] published by the Department of State, reveals that [Avraham Salmon] is assigned as [Economic Counselor to the Israeli Embassy,] Washington, D.C. (S)

This memorandum is being loaned to you by the Federal Bureau of Investigation and neither it nor its contents are to be distributed outside the agency to which loaned.
