PEDRO LUIS DIAZ LANZ, Internal Security - CUBA.

REMYLET FEBRUARY 25 LAST TO BUREAU.

TODAY MM 635-S ADVISED THAT YESTERDAY HE MET WITH PEDRO DIAZ  
AND HIS BROTHER, MARCOS DIAZ LANZ, AND WAS FURNISHED FOLLOWING  
INFORMATION CONCERNING PLANNED HIT AND RUN RAID ON CUBA BY BOAT.

PEDRO WILL DEPART FROM HARDIES YACHT BASIN, MIAMI, IN HIS 31  
FOOT "MOPPIE," LIGHT BLUE AND GREY IN COLOR, CAPABLE 50 MPH SPEED,  
AND RENDEZVOUS TOMORROW AT 1:00-2:00 PM AT DESIGNATED SPOT OFF  
FLORIDA KEYS WITH SMALL BOAT FROM WHICH WEAPONS WILL BE LOADED  
ON THE MOPPIE. THIS SMALL BOAT LOADED WITH WEAPONS AND SUPPLIES  
WILL BE TRAILER-HAULED FROM MIAMI IN CAR OCCUPIED BY SEVERAL  
CUBANS, INCLUDING MM 635-S, WHO IS SCHEDULED TO DRIVE BACK TO  
MIAMI WITH SMALL BOAT AND TRAILER AFTER RENDEZVOUS COMPLETED.  
ON FOLLOWING DAY BETWEEN 7:00 AND 10:00 AM, MM 635-S SCHEDULED  
TO MEET MOPPIE ON ITS RETURN TRIP FROM CUBA AT POINT OF ORIGINAL  
RENDEZVOUS. WEAPONS WILL BE TRANSFERRED TO SMALL BOAT AND BROUGHT  
BACK TO MIAMI VIA TRAILER AND CAR WHILE PEDRO RETURNS IN MOPPIE VIA  
SEA TO HARDIES YACHT BASIN.

CUBANS PARTICIPATING IN THIS OPERATION INCLUDE PEDRO AND MARCOS  
DIAZ, SALVADOR GARCIA OLLER, RAFAEL INCLAN AND FNU SOTOLONGO. OB-  
JECTIVE IS TO HIT SOME TARGET SUCH AS TANKER, FREIGHTER, OIL

REFINERY OR BUILDING ON SHORELINE OF HAVANA OR MATANZAS PROVINCE. WEAPONS UTILIZED WILL INCLUDE 20 MM CANNON, 30 CAL. MACHINE GUN, TWO THOMPSON SUBMACHINE GUNS, 1 BAR, HAND GRENADES AND AMMUNITION.

MM 635-S HAS BEEN INSTRUCTED TO ATTEMPT OBTAIN ADVANCE INFO CONCERNING POINT OF RENDEZVOUS.

[CIA ADVISED TODAY IT HAS NO OPERATIONAL INTEREST IN THIS MATTER.] U.S. CUSTOMS AND U.S. BORDER PATROL NOTIFIED PERTINENT FACTS ABOVE. [X] (u)

SUBSEQUENTLY, U.S. CUSTOMS ADVISED THAT PEDRO'S MOPPIE BEARING REGISTRATION NUMBER 74445 E PRESENTLY AT HARDIES YACHT BASIN, MIAMI. CUSTOMS WILL PLACE SURVEILLANCE TO DETERMINE DEPARTURE OF MOPPIE FROM MIAMI AND IS CONSIDERING USING COAST GUARD HELICOPTER TO INTERCEPT MOPPIE AFTER IT IS LOADED WITH GUNS. ALL LOGICAL EFFORTS BEING MADE TO PROTECT MM 635-S.

MIAMI WILL ADVISE BUREAU OF FURTHER PERTINENT DEVELOPMENTS AND SUBMIT COMMUNICATION SUITABLE FOR DISSEMINATION.
