On April 26, 1964 and June 17, 1964, MM-635-S, who has furnished valuable information in the past concerning subject, advised that DIAZ LANZ is devoting all his working time to speech making for pay, and no longer has any ambition to engage in any action against the CASTRO regime.

MM-635-S is in frequent contact with DIAZ and members of his family, and he is in a position to report any renewal of activity by DIAZ.

Further investigation is presently considered unjustified, but case will be reopened if future developments so justify.
