Subject voluntarily contacted the Miami Office on September 4, 1959, and stated that the reported 32 agents operating in the Miami, Florida area under the direction of RAUL CASTRO had been recalled to Cuba several weeks previously and that to his knowledge there had been no replacements sent. DIAZ also stated that he has not yet been able to establish effective contact with his "organization" in Cuba which was set up to report to him on the Communist Party situation there. However, DIAZ offered complete cooperation with the FBI and said he would immediately furnish
