Enclosed herewith are 9 copies of a letterhead memorandum, dated and captioned as above at Miami. (u)

MM T-1 is MM 639-S (u)

On 7/12/62, [WILLIAM MC CLAIR] Covert, CIA Agent Miami, Florida, advised that on 6/29/62, his office received a memo from CIA headquarters instructing to "make life difficult" for LA BORDE and that CIA headquarters wanted LA BORDE outside of Miami. CIA headquarters instructed to "include hoodlum activities" as a method of getting LA BORDE to leave the Miami area; however, CIA, Miami, did not go along with, or approve, CIA headquarters' suggestion. (S) (u)

Miami will maintain contact with [MM 639-S] and keep the Bureau advised. (u)
