IN SEPTEMBER LAST RESIDED ONE NINE TWO FIVE SOUTHWEST FOURTH STREET, MIAMI, FLORIDA. FURNISHED PERMANENT ADDRESS AS TWO ONE ZERO WILLIAM STREET, STRATFORD, ONTARIO. CLAIMED HE LEFT LONDON, ONTARIO, VIA TRANS-CANADIAN AIRWAYS ENTERING U. S. THROUGH CLEVELAND, OHIO, AUGUST SEVENTEEN LAST. CABLEGRAM TO LEGAL ATTACHE OTTAWA  
RE: INTERCONTINENTAL PENETRATION FORCES (INTERPEN)  
2-1693

ONLY PURPOSE IN ENTERING U. S. AT THIS TIME WAS TO VISIT FRIENDS.  
HE DENIED BEING INVOLVED IN TRAINING OPERATION BEING CARRIED ON  
BY HEMMING AND GROUP. IDENTIFICATION DIVISION WILL SEPARATELY  
FURNISH PRINTS WHEN RECEIVED.

NOTE: Dempsey, Canadian citizen, is one of several vagrant-  
type soldiers of fortune who were arrested recently by Customs  
in Florida and charged with illegal transportation of arms.  
Legat, Ottawa, requested we sucab particulars concerning  
identification of Dempsey for assistance RCMP since RCMP had  
no record of him. Legat requested we forward copies of  
Dempsey's prints and this being handled separately by  
Identification Division. Data being furnished Ottawa  
originated with INS Border Patrol. On 12/6/62 Donald Coppock,  
Assistant Commissioner, Enforcement, INS, who heads Border  
Patrol, advised SA Robert Haynes no objection to INS data  
being given RCMP. Cable being sent via State Department channels  
at no cost to Bureau, it being noted cable reply was requested  
by Legat.

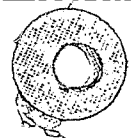
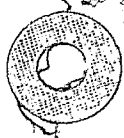
