Re Miami airtel to Bureau 6/21/63, with enclosures, and Bulet to Miami 7/23/63.

It is noted U. S.  $C_{u}$ stoms and police on 6/20/63raided the residence of CARLOS ZARRAGA and confiscated a quantity of arms and ammunition. This was as a result of information received from MM 639-5 and disseminated to U. S. Customs. (W)

ZARRAGA was last interviewed by Miami on 1/25/63 in case entitled, "POSSIBLE ANTI-CASTRO RAID SCHEDULED FOR ABOUT 12/16/62," Bufile 2-1787.

SA ROBERT JAMES DWYER conducted the interview and states it is a custom among Cubans to serve to visitors received at their homes or offices small demitasse cups of black, strong, bitter Cuban coffee. SA DWYER cannot recall if he was offered coffee or not but he doubts he drank it inasmuch as he does not like Cuban coffee.

ZARRAGA has not been checked, contacted or interviewed by Miami Office since 1/25/63.
