HE COULD PROVIDE NO FURTHER SPECIFIC INFO, EXCEPT THAT HE HEARD THAT THE COUNTRY WAS SWEDEN. ~~NO~~ INFO RECEIVED THAT GIANCANA WAS IN SWEDEN ON HIS TRIP, HOWEVER, HE WAS IN SWITZERLAND BRIEFLY.
