Re Miami airtel to Bureau, 9/30/70.

Reference is made to Miami airtel, 1/18/71, with LHM attached, to Bureau in the case entitled, "CUBANOS LIBRES - IS-CUBA", wherein it is reported that DONESTEVEZ had sold a 24-foot Piranha boat to Cubanos Libres. This boat is to be used reportedly in an operation against Cuba by Cubanos Libres. *(X)(u)*

*(X)* FMM 1337-S has been maintaining close contact with DONESTEVEZ, *(u)* but no information has been developed which reflects that DONESTEVEZ is about to participate in any illegal activities at this time.

Since DONESTEVEZ has a record of involvement in unauthorized activities in the past, this case will be kept pending for a reasonable period of time.
