Informant reports one night's operation totals \$130,000 with a net profit to J and J of \$11,500. Account for this operation maintained at First National Bank of Hammond, Indiana, under peculiar system of accounting involving series of dots and pin holes on checks. u

SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED THIS DATE HE WAS EMPLOYED AT THE J AND J PICNIC GROVE GAMBLING SPOT, WILL COUNTY ILLINOIS, DESCRIBED EARLIER AS GIANCANA, ET AL OPERATION, DURING NIGHT OF JULY 29TH LAST. TOTAL BANKROLL WAS \$130,000, NET PROFIT, \$11,500. ACCOUNT FOR THIS OPERATION KEPT AT FIRST NATIONAL BANK OF HAMMOND, INDIANA, UNDER PECULIAR SYSTEM OF ACCOUNTING. NO ENDORSEMENTS GIVEN ON CHECKS DEPOSITED ACCOUNT MAINTAINED AND RECOGNIZABLE BY SERIES OF DOTS OR PIN HOLES KEPT BY THE OPERATORS OF THE J AND J. OFFICIALS AT BANK KNOW SET UP, THEREFORE ABLE TO KEEP ACCOUNT AS DESCRIBED ABOVE. KRUSE HAS PROMISED INFORMANT HE WOULD "KEEP HIS EYES OPEN" FOR A GOOD SPOT FOR THE INFORMANT TO MAKE SOME MONEY. ROCCO PRANNO GIANCANA LIEUTENANT IN STONE PARK ILLINOIS ARRESTED BY STATES ATTORNEYS POLICE JULY 28 LAST FOR ASSAULT. HE ATTACKED A TRUCK DRIVER PARKED IN FRONT OF KEY LOUNGE FOR NO APPARENT REASON, BEAT HIM UNCONSCIOUS IN FULL VIEW OF STONE PARK POLICEMAN. ANTHONY SIGMORELLA, CHIEF OF POLICE OF STONE PARK AND COUSIN OF PRANNO, WOULD TAKE NO ACTION. ARMED AND DANGEROUS.
