SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. PCI [REDACTED]  
 [REDACTED] ALDERMAN OF 28TH WARD, CHICAGO, ADVISED BUAGENT THAT  
 ALDERMAN JOHN D'ARCO, FIRST WARD, HAD CONFIDED IN HIM THAT AT  
 TIME OF SUBJECT'S RETURN FROM MEXICO DURING SUMMER 1959 CUSTOMS  
 INSPECTION OF SUBJECT'S EFFECTS REFLECTED LIST OF NAMES INCLUDING  
 THAT OF D'ARCO. WHEN INTERVIEWED BY BUAGENT REGARDING REFERENCE  
 TO HIS NAME, D'ARCO PLEADED IGNORANCE RE REASON HIS NAME REFLECTED.  
 D'ARCO TOLD [REDACTED] HIS NAME WAS ACTUALLY PART OF SUBJECT'S GUEST  
 LIST IN CONNECTION WITH SUBJECT'S DAUGHTER'S WEDDING BEING PLANNED  
 AT THAT TIME. D'ARCO CLAIMED HE REFUSED TO REVEAL THIS TO INTER-  
 VIEWING AGENT INASMUCH AS HE DID NOT KNOW IF INVESTIGATORS WERE  
 AWARE A WEDDING WAS PLANNED, ALSO DID NOT WISH TO REVEAL NAMES  
 OF INVITED GUESTS TO FBI. SHELDON ROSING, FLOSSMOOR, ILLINOIS,  
 ACCOUNTANT, ADVISED BUAGENTS HE FORMERLY HANDLED BOOKS FOR TWIN  
 FOODS PRODUCTS, TRADEWINDS RESTAURANT AND NIGHT CLUB AND CONTIN-  
 ENTAL PROCESSING. STATES HE IS QUITTING ACCOUNTING BUSINESS AND  
 WILL MAKE AVAILABLE TO FBI ALL RECORDS, PAYROLL LISTS, ETC. SAM  
 "TEETS" BATTAGLIA, CHICAGO HOODLUM AND LIEUTENANT OF SUBJECT RE-  
 PORTEDLY HAS FINANCIAL INTEREST IN ABOVE ENTERPRISES. RECORDS  
 FURNISHED BY ROSING UNDOUBTEDLY WILL REVEAL EXTENT OF BATTAGLIA'S  
 INTERESTS. GIANCANA ARMED AND DANGEROUS. CG 6486-C\*, ADVISED  
 YESTERDAY OF POSSIBILITY THAT GIANCANA WAS IN THE VICINITY OF THE  
 INFORMANT; HOWEVER, NO PERTINENT COMMENTS WERE NOTED OTHER THAN  
 THE FACT THAT ONE "MOE" BRIEFLY DISCUSSED A MATTER WITH AN UNKNOWN  
 INDIVIDUAL. U
