Information in Chicago memorandum dated 7/13/62 was furnished on 8/30/62 to the Swiss Central Police Bureau, Bern, Switzerland, who advised on 9/7/62 that the information which we had furnished had not enabled them to develop any criminal record concerning SAMUEL M. GIANCANA or PHYLLIS JEAN MC GUIRE. (S)(R)(u)

The Swiss authorities have stated that in order to conduct a more complete inquiry throughout Switzerland concerning a possible marriage between the above-mentioned individuals, they would like to know additional background data relative to the reasons prompting the Bureau's request for such information. This office is not in possession of such data and if it is felt that additional inquiry is desired in this matter, it is requested that we be furnished some further background data relative to the subject and his activities so that we may respond to the Swiss inquiry in making any further request of them.
