|| certain property owned by SEVEL. The man indicated that SEVEL was to be killed by Communist agents. The priest was not clear concerning the reason for SEVEL's jeopardy and could furnish no additional information in this regard.

The priest stated that he did not believe the man to be a crank because his motive in appearing at the church was primarily one of religious concern and the above information concerning the man's background and re SEVEL was incidental and unrelated to the main discussion. The priest advised that the man spoke with a Slavic accent, possibly Russian, was well dressed and presented himself intelligently and credibly. ||

Father BUCKLEY described the unidentified man as follows:

The Los Angeles Office was advised by CSLA 3184-S, who furnished information to SA WILLIAM JOHN NOLAN on December 24, 1957, that on 12/22/57 an anonymous complainant had advised the Los Angeles Police Department Business Office that JOSEPH SEVEL (phonetic), 1153 Denton Drive, Dallas, Texas, would soon be killed by the Reds. No action is being taken on this by the Los Angeles Police Department.

This information is being furnished to Dallas for whatever action deemed appropriate. ||
