Enclosed for the Bureau are nine (9) copies of
a letterhead memorandum reflecting information concerning
the CCC.

Due to their interest in Cuban matters, one (1)
copy of instant letterhead memorandum is enclosed for
Miami.

The first source mentioned in the enclosed
letterhead memorandum is ~~PSI~~ CARLOS DE LA VEGA, director
of the Latin American section of Ochsner Clinic in New
Orleans. **(S)(u)**

The second source referred to in the letterhead
memorandum is PSI SALVADOR ACOSTA.

New Orleans is placing this matter in a closed
status due to the fact that the group is no longer func-
tioning and due to the lack of support by Cubans in the
New Orleans area. New Orleans will re-open this case
upon receipt of information that the CCC has reactivated
itself and is coordinating activities of anti-Castro
groups in New Orleans.

The enclosed letterhead memorandum is being
classified "CONFIDENTIAL" to protect informants of con-
tinuing value.
