 ADVISED THEY DEPARTED NYC 3:30 AM AND ARRIVED BOX WOOD  
 MOTEL, OWINGS MILLS, MARYLAND, 9:30 AM INSTANT. MCGUIRE  
 REGISTERED ROOM 48, SECOND FLOOR. EN ROUTE, AT HOWARD  
 JOHNSONS RESTAURANT ON NEW JERSEY TURNPIKE 2 MILES SOUTH OF  
 LINCOLN TUNNEL AT 3:35 AM MC GUIRE CALLED FROM PUBLIC  
 TELEPHONE. SHE INFORMED PCI SHE FAILED TO REACH SUBJECT IN  
 CHICAGO. MC GUIRE IRRITATED BECAUSE LONG DISTANCE OPERATOR

 MOTEL CONTACTS SINCE SOME MOTEL EMPLOYEES CONSIDER MC GUIRE  
 PERSONALITY AND PROBABLY WILL ACCORD HER VIP TREATMENT.  
 CHICAGO KEEP BALTIMORE INFORMED OF SUBJECTS ACTIVITIES.  
 COPIES MAILED TO NEWARK AND PHILADELPHIA. GIANCANA CONSIDERED  
 ARMED AND DANGEROUS. MAIL COPIES SENT TO NEWARK AND  
 PHILADELPHIA.
