PCI ADVISED UPON RETURN TO NYC HE DOUBTS SUBJECT WILL VISIT MC GUIRE AT BOX WOOD MOTEL BECAUSE OF SHORT DURATION OF STAY AND SINCE SHE IS THERE FOR REHEARSALS. MC GUIRE WILL TRAVEL IN ROAD SHOW "ANNIE GET YOUR GUN" STARTING AUGUST 6, 1961.
