On 1/21/69, Mrs. CARMEN ARCE DE PLANAS, owner of residence at Calle Mallorca #121, advised that QUERALT had resided in the upstairs apartment at that address until approximately two years ago at which time he moved to Miami, Florida. She did not know his Miami address.

On 1/21/69, SJ 492-S (SJ T-1 in enclosed LHM) advised that he is personally acquainted with QUERALT. He indicated that QUERALT moved to Miami in 1966, after his business had failed in San Juan. QUERALT has not returned to San Juan since that time. Source did not know QUERALT's address in Miami. (X)(u)

SJ 492-S has previously identified NICOLAS ALVAREZ CAMPS as the current MIRR delegate from Puerto Rico. He characterized ALVAREZ as a poor leader and indicated that ALVAREZ was shocked when he learned that he had been selected for the MIRR position. ALVAREZ resides at Calle Parnaso, #563, Summit Hills, Rio Piedras, Puerto Rico, telephone 782-2288. (X)(u)

On 1/20/69, a surveillance was conducted in the vicinity of ALVAREZ's home. ALVAREZ and MARCELINO GARCIA JIMENEZ were observed to leave the home and proceed to Los Robles Apartments, Rio Piedras, where they attempted to contact RAMON BARQUIN LOPEZ, the owner of Antilles Military Academy, Guaynabo, Puerto Rico. BARQUIN is the subject of Bufile 105-83676, San Juan file 105-4966. Thereafter both individuals drove to the home of GLAUCO VAILLANT, K-9, Bamboo Drive, Torrimar, Guaynabo, Puerto Rico. The following vehicles were observed parked near the VAILLANT home:

1962 Chevrolet bearing 1968 Puerto Rico license 902-739, registered to JORGE MORALES ORTEGA, Santa Rosa, Bayamon, Puerto Rico.

1964 Oldsmobile bearing 1968 Puerto Rico license 810-095, registered to MARCOS A. GOMEZ, JR., 426 San Alejandro Street, Sagrado, Corazon, Rio Piedras, Puerto Rico.
