According to the informant, FAUGNO had apparently talked to MARTIN SCHINDLER, who is operating the Cabana Club, and was advised that the club is \$25,000 in debt and SARUBBI, who holds the original lease, is threatening to foreclose. According to NK 2381-C-TE, ZICARELLI personally guaranteed the \$185,000 debt. Informant further stated that FAUGNO wanted KONIGSBERG "hit" in the jail now. ZICARELLI has also threatened to have KONIGSBERG "hit," but does not want him "hit" at the present time.

On 11/5/64, NK 2381-C-TE advised that AL BRAWER contacted ARMAND FAUGNO at FAUGNO's headquarters located behind the Duncan Truck Stop, 376 Duncan Avenue, Jersey City, N.J. According to informant, FAUGNO told BRAWER that he had \$285,000 invested in the Cabana Club and had two partners in this venture. He further stated that in addition to the \$25,000 in debts that ZICARELLI had been told existed, there was an additional \$19,000 in liens, withholding taxes and other debts that had to be paid off.

The informant advised that HAROLD/KONIGSBERG recently wrote a letter to JOSEPH ARTHUR ZICARELLI in which he stated that TONY PROVENZANO and his brother, as well as a man named LALA, had an interest in the Cabana Club.

TONY PROVENZANO is probably identical to ANTHONY
PROVENZANO, President of Local 560, International Brocherhood
of Teamsters (IBT). LALA is probably identical to RALPH
PINELLA, who has been described as a top lieutenant in
FAUGNO'S numbers shylocking operation.
