as an enclosure to the Bu, the WFO indices reveal that on 8/28/57, WF 279-S advised that one RONALD MAY of the "Capital Times", Madison, Wisconsin, contacted the Embassy of the USSR regarding an invitation to a November 7 reception, not further identified. According to the informant, RONALD MAY gave as his address, Apartment B21, Monroe Building, Presidential Courts, Alexandria, Va.

The Washington Metropolitan Area Directory, dated September, 1959, lists a RONALD W. MAY, Presidential Gardens, Alexandria, Va., telephone number KING 9-8957.

A review of the files of the WFO revealed the following information concerning WILLIAM A. ROBERTS:

- (1) WFO file 77-958 captioned "WILLIAM A. ROBERTS, DEPARTMENTAL APPLICANT." A review of this file disclosed that a satisfactory investigation was conducted concerning the subject in 1935.
- (2) WFO file 100-888. In the report of SA T. W. DAWSEY, dated 1/22/41, captioned "SOCIALIST PARTY, D. C., IS - C," it was ascertained through the assistance of confidential informant C-21 that the name of WILLIAM A. ROBERTS, 4440 Lowell St., N. W., telephone number EM 5405, was contained in a list of names and addresses of persons attending the 1940 Socialist Party Convention, who made contributions to this Party in Washington, D. C.
- (3) WFO file 100-1522. The report of SA T. W. DAWSEY, dated 5/15/41, captioned "NATIONAL LAWYERS GUILD, IS - C," contained the minutes of the National Executive Committee of the National Lawyers Guild from 2/19/37, to 11/30/40. The minutes of the National Executive Committee of 2/19/37, revealed that WILLIAM A. ROBERTS, D. C. Bar, was present and amenable to the suggestion of the Nominations Committee that he be
