OR ROLANDO MASFERRER. HE HAS NOT SEEN VIXAMA SINCE JANUARY SIXTYSIX.

HAS NOT SEEN CANTAVE FOR ONE AND ONE HALF YEARS. HE LAST SAW
New York City
MASFERRER THREE WEEKS AGO IN NYC, AT WHICHTIME THEY TALKED IN GENERAL
TERMS OF THE HAITIAN-CUBAN SITUATION. FATHER GEORGES HAS NO KNOWLEDGE
OF ANY ARMS SHIPMENTS FROM NYC TO MIAMI, FLORIDA, AND STATED THAT NO
COMMITMENTS OR PLANS WERE DISCUSSED DURING HIS LAST CONTACT WITH
MASFERRER.

ENRIQUE A. GARCIA, IDENTITY KNOWN TO BUREAU, CLOSE ASSOCIATE
