Concerning phone [WH 2-3789] it has been ascertained through the Montgomery County, Maryland, current issue of the City Directory that phone Number WH 2-3789 is listed to one EMIL G. GARRETT, 4511 Strathmore Avenue, Garrett Park, Maryland, (a suburb of Washington, D. C.), and his occupation is listed as USA, and his wife is shown as MARJORIE. WFO indices regarding [GARRETT] are negative. WFO will conduct a discreet preliminary investigation to ascertain his background and thereafter make further recommendation concerning investigation of this individual.

The subscriber to unlisted phone Number [WH 6-5972] is currently being ascertained.

Concerning STERLING, CARLOS MARQUEZ, 4600 Connecticut Avenue, Apartment 705, this individual is the subject of the case captioned "CARLOS MARQUEZ STERLING, IS - Cuba; RA - Cuba," Bureau file 109-321, New York file 105-61131, and Miami file 105-2476. New York is office of origin concerning him and his background and activities are well known to WFO, New York and Miami so that further investigation concerning him is not recommended. It should also be noted that at one time WFO utilized STERLING as a source of information under WFO file 134-3192, Bureau file 109-321; but when he moved to New York City during the Summer of 1963, his services as a source of information could no longer be used by WFO.

Concerning DICK PIERROT, 2701 31st Street, N. W., this individual appears to be identical to the case captioned "ALBERT OGDEN PIERROT, aka ALBERT O. PIERRO, A. OGDEN PIERROT, 'DICK,' PSI - Cuba," Bureau file 100-133192, WFO file 134-3398. In 1960 PIERROT's services were utilized briefly by WFO as a PSI, since that one time he sold airplanes to the Cuban Government shortly after CASTRO assumed the position of Premier. His background is well known to WFO and it does not appear that any additional investigation concerning him is warranted.

The Bureau and Miami will be furnished additional information concerning [EMIL G. GARRETT] and unlisted phone Number [WH 6-5972] if it is developed.
