CIA furnished information indicating that subject, an American soldier of fortune, stated that Marcos Diaz Lanz, the brother of Pedro Diaz Lanz, had approached subject to patch up differences between subject and Pedro Diaz Lanz and to enlist subject's cooperation in anti-Castro activity. Subject allegedly agreed to assist in planning and execution of mission even though only information he was given was that an air strike was involved in which Pedro Diaz Lanz would be the pilot.

IMI 635-S is extremely close associate of Diaz Lanz's brothers and has previously furnished information which thwarted a planned operation of Pedro Diaz Lanz to attack Cuba.
