On July 15, 1969, NO 1075-C advised he has borrowed many times from the Rex Finance Company, and only recently failed to make a payment on schedule, and someone at the company was giving him a bad crédit reputation. Source therefore went to JOE BOHRER and severly reprimanded him, possibly included a threat, and left. Later MORRIS LANSBURG called source in and asked him to go easy with BOHRER, indicating that he was closely related and said "If you hurt him, you hurt me." Source advised that this LANSBURG is the same MORRIS LANSBURG that previously brought sack full of money (Bills) to CARACCI at the amusement company office. The above was furnished to SA L. M. SHEARER, JR.

On August 12, 1969, source advised that EMANUEL LANSBURG, 544 Andrew Street, New Orleans, is LANSBURG who brought large amount of bills in a bag to CARACCI as reported in the past. This LANSBURG was present when CARACCI called the Flamingo Hotel in Las Vegas to get his gambling losses back. He told CARACCI not to worry about the losses when the losses were being discussed before the telephone call. NO 1075-C has not observed MORRIS LANSBURG, former owner of the Flamingo Hotel in Las Vegas in connection with CARACCI.

B COVER PAGE NO 1677-C-TE advised July 31, 1969, that FRANK CARACCI had informed him that the defense in the bribery case will be that the two men approached him on behalf of the IRS Agent and that he made no overt acts to the IRS Agent and delt strictly with the other men.

The above information was brought to the attention of US Departmental Attorney JOSEPH TAFE.
