Davidson noted that document 1 above has a reference number of 447 which he assumes may be a distribution copy count (S)

Davidson added that Julian was due back in Washington, D. C. on November 30, 1967 (S)

On December 1, 1967, Davidson advised that Julian had telephonically contacted Davidson from New York, New York, on November 30, 1967. Due to weather conditions Julian was unable to come to Washington, D. C. In response to Davidson's question, Julian indicated he had "in hand" the "Cogswell and Harrison" draft and would make it available for Davidson's perusal. No definite meeting was arranged due to Davidson's travel schedule through the week of December 8, 1967, as Davidson would be traveling outside the continental limits of the U. S. (S)

WF T-1, who is familiar with certain phases of Haitian activity both in Washington, D. C. and New York, furnished the following information: (S) (X) (U) (U)

On November 29, 1967, WF T-1 advised that Henry Vixama, consultant to the Chad Government, and a professional Haitian revolutionary, had been in Washington, D. C., recently, exact date or dates unknown to source, and had met with various individuals in the Washington, D. C. Haitian community, speaking about his "project" (S) (X) (U) (U)

WF T-1, on December 1, 1967, learned that Vixama, had met with Robert Bazile, Haitian exile, now employed as an economist at the Pan American Union, Washington, D. C. Vixama personally furnished Bazile [documents 1, 2 and 3] (C) being [documents 1, 2 and 3] (C) identical to those furnished to Davidson above). [document 1] (C) given Bazile contained [reference number of 436] (S) (X) (U) (U)

WF T-1 explained that the left hand marginal titles appearing in [documents 1 and 2] represent Vixama's self declared (S) (X) (U) (U)

On Friday, 11/24/67, subject telephonically  
contacted DAVIDSON from Miami, Florida, stating he wished  
to come to Washington, D. C., meet with DAVIDSON and  
introduce HENRY VIXAMA, consultant to Chad Government.  
DAVIDSON declined stating he had house guests. A second  
telephone call on 11/25/67, to DAVIDSON determined that subject  
had traveled to Washington, D. C. DAVIDSON again declined  
to meet excusing himself because of house guests. A third  
telephonic request was placed to DAVIDSON on 11/26/67.  
DAVIDSON reluctantly agreed, due to subject's travel, to  
receive subject and VIXAMA at DAVIDSON's home, post 9 p.m.,  
on 11/26/67

DAVIDSON stated that should he receive a reply it indicates various possibilities: 1) that Cogswell and Harrison are consumately stupid in furnishing any "packaged revolutionary deal"; 2) that JULIAN and VIXAMA are dealing with other U. S. investment interests unknown to DAVIDSON; 3) that a separate pool of money outside of the sum requested of DAVIDSON possibly exists toward the total of two and one-half millions. (S)

DAVIDSON stated that with the few words VIXAMA did get in, he gives the impression that his activity is known to and has the approval of the U. S. Department of State and the CIA. DAVIDSON's personal reaction to this was one of skepticism and disbelief. (S)

JULIAN emphasized that this invasion plan of Haiti is possible and workable. Particularly it would be organized outside the U. S., it would employ mercenaries, and lastly that VIXAMA is capable and qualified to establish a government. (S)

DAVIDSON concluded that JULIAN is due back in Washington, D. C., on 11/30/67. DAVIDSON will furnish results of 11/30/67 on 12/1/67. (S)

On 11/29/67, WFO [1338-S] advised that VIXAMA had been in Washington, D. C., met with various individuals in the Washington, D. C., Haitian community and spoke about his "project". Details as known to WFO [1338-S] will be obtained on 11/30/67. (S)
