Information contained in retel does not indicate any violation within jurisdiction of FBI. Arms smuggling and gunrunning are under jurisdiction of Bureau of Customs. In absence of any information indicating instant matter within Bureau's jurisdiction, Butte and Miami instructed to advise Bureau of Customs of available information and take no further action.

NOTE ON YELLOW:

Butte received information from RCMP that subjects possibly involved in arms smuggling or gun running from Miami to Cuba. Butte indicated it would interview one of subjects upon return from Canada in about ten days.
