acquire more knowledge of law enforcement matters, because at a recent Police School held in New Smyrna Beach, Florida over twenty-five of the officers attended on their own time and drove a considerable distance to and from the school at their own expense.

The department lacks leadership and the esprit de corp is strictly at a low ebb. When ROSIER was made Acting Chief of Police he took Detective Sergeant A. G. LAYNE out of the Detective Bureau and made him Night Sergeant and put in LAYNE's place a motorcycle policeman with no previous detective experience and thus impaired what little efficiency the Detective Bureau had. This change was made because Mayor PADGETT "had a mad on for LAYNE".

E. POLICE TIE-UPS WITH ORGANIZED CRIME

There can be no doubt of the connection between the police and the gambling element in the city, for the BEACH CLUB, SEABREEZE GOLF AND TENNIS CLUB, and all three horse bookie joints are within the city limits and the police had authority to take such action as would close the joints if they had so desired. But the police were ham-strung by the Mayor and the City Commissioners who were getting the "gravy" and they were told to "lay off the gamblers". It is seriously doubted that any of the individual officers are being paid off, but previous allegations have been made indicating that TOM JOHNSON had been paid off by EARLY WARNER and there is little doubt that Acting Chief of Police BILL ROSIER is getting his share.
