CG SIX FOUR FIVE SEVEN DASH PC ADVISED YESTERDAY THAT SHE HAS LEARNED FROM ACQUAINTANCES OF GIANCANA THAT HE IS DEFINITELY MARRIED TO PHYLLIS MC GUIRE, OF MC GUIRE SISTERS SINGING TEAM. DATE AND OR PLACE OF THIS MARRIAGE IS NOT KNOWN TO THE INFORMANT. (u)
