ADMINISTRATIVE:

The following information, received from MEX-18 and MEX-19, is being set out herein rather than in enclosed report because it is felt that this information, derived from their intimate association with the subject, if reported in detail, would tend to disclose informants' identities.

On 2/20/62, subject was asked about MERIDEL LE SUEUR (Bufile 100-105909), who had recently been in Cuernavaca, Mexico. Subject told them that LE SUEUR should not be contacted and that any messages could be sent through her.

The same date, she mentioned that her citizenship papers had not been signed.

Informants reported 3/15/62 that subject was collecting money for a school to be sponsored by the Mexican Communist Party (PCM) to train leaders from all over Mexico.
