The only sources of this office who are in contact with CHARLES SMALL and who would be in a position to have some knowledge of SMALL's activities and contacts are MEX-18, MEX-19, MEX-48, and MEX-61. *(c)*

It is to be noted, however, that a review of the information received from CIA, Mexico as a result of the technical coverage maintained at SMALL's residence in September, October, and November, 1963, produced no indication that OSWALD visited the store or was in touch with SMALL. *(c)*
