JOHNSON stated that recently GUS HALL, General Secretary, CP, USA, Dr. JOSEPH PARKER MORRAY, HERBERT APTHEKER and JOHNSON must meet to discuss the formation of the American Institute of Marxist Studies. The discussion concerned in part Dr. JOSEPH PARKER MORRAY and whether he should be taken into the CP fold. The Institute, as established, is supposed to be non-Communist to impress all progressive
