matters for the MUGAR family interests. DONN advised that he last heard that the subject, who travels extensively, was in Florida. He remarked that the subject has no real need of gainful employment due to her family's extensive wealth. (S)(u)

On 4/8/69, NORMAN CHALETZKY, established source, Norge Realty, Beacon Street, Boston, advised that STEPHEN P. MUGAR is a multimillionaire philanthropist and businessman who enjoys an impeccable reputation both here and abroad. MUGAR has donated huge sums of money to academic institutions and charities. As an example, he recently donated the Mugar Library to Boston University. (S)(u)

"Who's Who" lists the MUGAR children as DAVID GRAVES and CAROLYN JANE MUGAR. (S)(u)

~~EX Mugar~~ Boston recommends against interview of captioned subject who, on the basis of the above information, would not appear to have any intelligence value. (u) (S) [184 Clifton St., Belmont, Mass.] (u) (S)

Although Boston is closing this case as the office of origin wherein subject resides, this does not preclude investigation by New Orleans concerning subject's relationship with MARK LANE. (S)(u)
