Review of subject's file at Headquarters indicates that as of 7/12/73 Carolyn Mugar was the subject of a closed file with the Boston Office being the last office of origin. A further review of Headquarters indices indicates that one Carolyn Mugar, apparently identical to the subject, has become extremely interested and involved in American Indian Movement (AIM) activities at Rapid City, South Dakota. This information was received from BT 545-SI upon the latter's return from the Vietnam Veterans Against The War/Winter Soldier Organization (VVAW/WSO) Steering Committee Meeting at St. Louis, Missouri, August, 1973. No information to this effect appears in subject's file at Headquarters.

Accordingly, both the Butte and Minneapolis Offices should review indices for all information concerning the Carolyn Mugar active in AIM activities and furnish same to Headquarters and the Boston Office. Upon receipt of this information, Boston should conduct sufficient investigation to determine that such information pertains to the subject, verify subject's present location and activities and advise Headquarters of the results in appropriate form accompanied by a recommendation as to any additional action deemed necessary.
