

He is a remarkable individual with a great deal of ability for his age. He possesses an unusual amount of energy. I know nothing of an unfavorable nature about him.

I would say that his loyalty and patriotism are definitely the very best. He is notionly not a political extremist, but I would describe him as just the contrary. He is a person who is very good in handling confidential information. I would not hesitate to recommend him for any kind of a sensitive assignment involving our country.

The file indicates that he was employed by Durst Manufacturing Company of 409 Lafayatto Street, New York City from August, 1945 to November, 1945; from June, 1948 to September, 1946; from June, 1949 to July, 1949; from July, 1950 to March, 1951.

The file reflects that prior to being drafted for Military Service in January, 1945, he served as a Cadet from October, 1943 to January, 1944.

The file contains information furnished by the subject that he testified in Williamstown, Massachusetts as a witness on behalf of a Negro who had been refused a haircut in a local barber shop. The plaintiff won the case with the aid of Mr. Redlich.

Subject states that in May, 1950, he wrote a paper entitled "Corporate Liguidation and Income Tax" which appeared in the Tax Law Review.

He also wrote a paper entitled "Private Attorneys - General; Group Action in the Fight for Civil Liberties," on unalimed comment 58 Yale LJ 574-598, (1949).

He stated that he also wrote "Triel Judges Duty to Call Witnesses in Rep Ipsa Loquitur Cases", an unsigned article 58 Yale LJ 1, (December, 1948).

In response to a question whether the subject believed in our basic form of government, he replied "Yes, I believe the basic principle underlying our form of government in my opinion, is the principal of free elections made real by the guarantees of free expression and free worships Given this framework, it becomes possible for our government to meet changing economic and social problems without causing any breakdown in our political structure. Only a government such as ours, which is ready to edapt itself to the needs of the nation, can retain the blessings which free and orderly government provides. While other nations are forced to resort to ruthless tyramics of the left or right, ours can still serve and preserve our liberties. I believe in the principles underlying our form of government because they offer the best possible hope for achieving a society in which we can be politically free and economically secure".

In ensure to the question "hre you pledged to aid in effecting changes in our form of government", the subject ensured "No".

In ensuar to a question "Are you a member of any party or organization created for such purpose or the propagandising thereof", the subject answered " No".

In answer to a question "Gen you conscientiously end <u>do</u> you affirm you are, without any mental reservation, layal to the Covernment of the United States of America", the subject answered "Yes".

The file contains a copy of Certificate of Birth Record No. 14128 issued at Bronz, New York City, indicating that he was born on November 12, 1925.

The file contains many letters by the persons given as reference which very highly praise the subject. Among the persons sending those letters was leving Kapling, 120 lorrain Avenue, FA. Vernon, New York who stated that they knew the subject from 1940 to 1951; Professor Raile Despres, of Williams College, Massachusetts, who knew the subject from 1945 to 1950.

The file contains a photoetatic copy of an Monorable Discharge concerning the subject, Army Scrial Number 12225769 from Company I, 347 Infantry, Iosued at the Station Mospital, Camp Butner, North Carolina and dated August 15, 1945.

The file indicates that subject received educational benefits under Rublic Lew 16.

The file contains favorable replies to inquiries cent to the principals of Willson Junior High School and A. B. Davis Junior High School, Mt. Vermon, New York; from the Registrary of Williams College and Yale University.

The file finally indicates that Certificate No. A 15298 was issued by the State Board of Lew Resminers of the State of New York on Jerusiy 8, 1951 indicating that the subject was qualified by exemination for the practice of law in the State of New York.
