On April 16, 1964 he reentered Denmark from London, England, and he stayed at the Hotel Viking, Copenhagen, April 16 and 17, 1964 and at the Hotel Skovriderkroen on April 17 and 18, 1964. (c)

On April 10, 1964 LANE delivered a lecture to the "Students' Union" in Copenhagen concerning the assassination of President Kennedy. In this regard, T-1 advised that a known Danish Communist, JORGEN THEILGAARD JACOBSEN, a lawyer, born April 11, 1919, took the initiative in forming a Danish committee for the main purpose of obtaining information on the continued investigations into the assassination. Further, this committee intends to have translated and published a book which LANE is writing on LEE HARVEY OSWALD's part or innocence in the murder. (c)

JACOBSEN and LANE became acquainted sometime ago when attending the Congress of the "International Association of Democratic Lawyers" in Budapest and they intend to continue the contact as MARK LANE will supply the Danish Committee with all new material on the assassination. (c)
