"12/9/63

"On 12/6/63 a Buffalo Branch Workers World Party (BB WWP) meeting was held at headquarters, 831 Main Street, Buffalo, N.Y. Ernie Weissman was Chairman, Helen Richardson, Recording Secretary, and Loretta McNiff, Financial Secretary. McNiff reported balance on hand of \$47.81.

"Helen Richardson read a communication from Sam Ballan regarding a special edition of 'Workers World,' which concerned the assassination of President Kennedy. In this communication Ballan mentioned that National Headquarters of WWP plans to put out other special editions, if necessary, to keep the people advised of current events.

"Milton Neidenberg gave the Organizer's report. He said that the Cuban Hurricane Relief meeting scheduled for 11/23/63 at the Richford Hotel, Buffalo, at which V. T. Lee from New York City, National Chairman of the Fair Play for Cuba Committee, had been scheduled to speak, was canceled due to the assassination of President Kennedy, and as they did not know what public opinion would be if the meeting was held as scheduled, and they did not want any trouble.
