"Dec. 9, 1963
Meeting at CAMD Headquarters

"Mr. Desofi saw Miss Berta Green from CAMD after receiving a call. Mr. Marvin Secal? was also present at their offices at 168 W 23rd St.

"Miss Berta Green said that the Monroe kidnap case will be brought to trial in February and that they need \$5,000 for the defense lawyers, \$1,500 is required within the next two weeks. Mr. Marvin Secal asked Mr. Desofi many questions about the Fair Play, for instance, if, in Mr. Desofi's opinion, FPCC could be brought back to life if Mr. Lee would be eliminated as head. He also questioned him about Mr. Lee's organizational abilities
