Information in referenced report pertaining to 7/26 RM meeting of 8/5/61 was extracted and paraphrased from a report of PH 563-S which contained further information identifying those present at the beginning of the meeting as JULIO CARRERAS, SILVINO ALONSO, JOSE SOTO, MIGUEL MORERA, and PH 563-S. It was to be discussed at the meeting a communication MORERA had received from Cuba. Before the matter could be taken up, ALBERTO BAEZ arrived with SILVERIO HERNANDEZ. All present were 7/26 RM members, except HERNANDEZ. He is not a member of the 7/26 RM and, according to PH 563-S, he is not trusted by some 7/26 RM people; however, over the past couple of months HERNANDEZ has been friendly and associating with BAEZ to obtain 7/26 RM information for the Philadelphia Office on a voluntary basis. The Philadelphia 7/26 RM, according to PH 563-S, has not been holding specified meetings solely for 7/26 RM business in the past and no known membership list is available to date. A list of 18 names was provided by PH 566-S on 7/11/61, which is considered by her to be members and sympathizers of the group. She had seen this list in the possession of ALBERTO BAEZ, new Financial Secretary of the 7/26 RM in Philadelphia. One of BAEZ' duties that he has assumed is distribution of "Bohemia." (X)(u)
