The possibilities suggested by Buairtel have been discussed with NK(2266)-S, NK(2227)-S, and WALDO [S] PSI, who are all members of the JULY 26th MOVEMENT. Although the chances for advancement of [REDACTED] and NK(2266)-S are not great at the present time [S] they have advised that they will exert every possibility to advance themselves within this organization.

[S] NK(2227)-S was mentioned by FILIBERTO ROJAS, the Coordinator at Hoboken, as one of five individuals as a potential leader at Hoboken when ROJAS left the United States on 9/28/61 for Cuba. Although this informant was not selected, he continues to be highly regarded by the membership.

However, on 11/8/61, this informant advised that he feels that now would not be an advantageous time to try to advance to a leadership position. He stated that the leadership is extremely jittery and that if they feel rightly or wrongly that various leaders might be in danger of imminent arrest, they would be ordered back to Cuba. It is noted that the new Coordinator at Hoboken has been reported to have fled the United States.

If one was ordered back to Cuba, then no possible excuse or reason could be possibly be offered or should be offered by a loyal member for not going.
